### **2009 Industry Assessment Rates**

#### **NAICS: North American Industry Classification System**

*WorkSafeNB used NAICS coding to establish the 2009 assessment rates. As a result employers have been assigned to new industries, industry groups and rate groups. Most employers will continue to be classified with most of the same industries as before and their assessment rates will not be affected significantly by this change. Others will fall into different industry and rate groups. The few industries with significant basic rate changes will have a maximum limit applied annually until the target basic rate is met. Basic rate decreases will be limited to 20%. Basic rate increases will be limited to the greater of 20% or \$0.20. Experience rating, the comparison of qualifying employers to others in their rate group leading to rate surcharges or reductions based on performance, will continue to be applied as usual.*
